Adjustments to your original orders may be requested until Tuesday, April 28, 2020 and will be accommodated to the extent possible. In the event that you must cancel your picnic area or tent suite order, your payment (less a cancellation fee of \$100.00) will be refunded only if we can replace your reservation with a company from the waiting list.
